A QUICK REFERENCE GUIDE TO USING MLA STYLE

General Guidelines for Writing a Works Cited Entry for a Database Source:

1. Cite information for the original source following MLA style for printed sources but omit "Print" at the end.
 2. Give the title of the database (*italicized*).
 3. Write GALILEO (all caps, followed by a period).
 4. Give the medium of publication (Web, followed by a period).
 5. Give the date of access (day/month/year, followed by a period).
- REMEMBER: All Works Cited entries are double spaced.**

Author/Byline (if available). "Article Title." *Newspaper Title* date [includes day/month/year], edition, section name/number: Page numbers of original article. *Database Name*. GALILEO. Web. Access date [day/month/year].
